



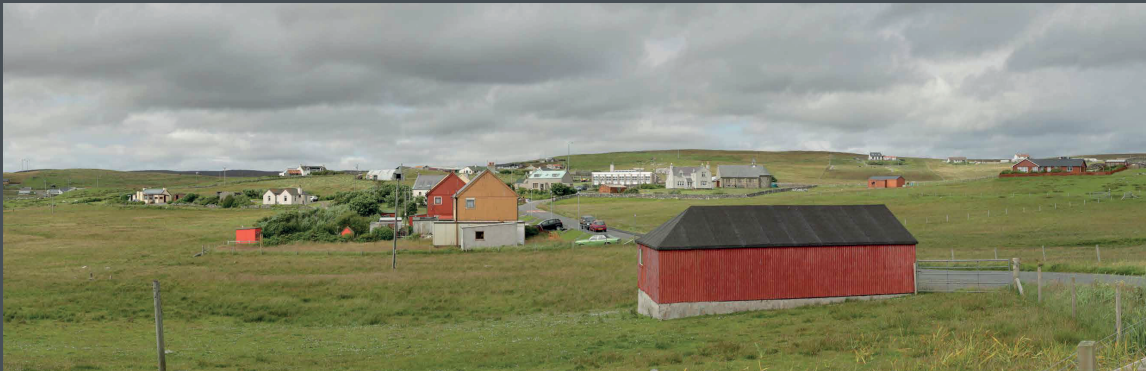

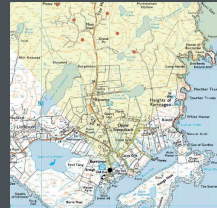

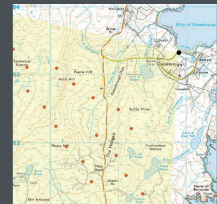

### Second Round of Beaw Field Wind Farm Exhibitions

I am writing to you regarding a second set of public exhibitions Peel Energy is holding concerning our potential wind farm at Beaw Field in the south east of Yell.

Peel Energy acquired the rights to develop the Beaw Field Wind Farm earlier this year and is now in a position to present a final design prior to the submission of a planning application to the Scottish Government. Previous consultations in April of this year proved very successful, with 82% of attendees indicated they were supportive of our plans for the site.

Based on our work so far, we are proposing 17 turbines up to a maximum height of 145m. Because of the size of this development, the application will be determined by the Scottish Government.

The exhibitions will take place over two days as follows:

- **Wednesday 7<sup>th</sup> October** – Burravoe Public Hall, 2 – 7pm
- **Thursday 8<sup>th</sup> October** – Mid Yell Public Hall 2 – 7 pm

Representatives of Peel Energy will be available to answer questions from members of the public, elected Councillors, local businesses, council officials and any others who attend.

Other Information available at the exhibition will include:

- More about renewable energy and wind power in particular.
- Maps of the proposed wind farm showing locations of turbines, and associated infrastructure.
- A 3D computer simulation of the proposed wind farm allowing people to see what the wind farm will look like from any part of the local area.
- Feedback and analysis gained from the first round of public consultations.

If for any reason you are unable to make the proposed times, we would be happy to meet you for a separate meeting in Shetland sometime in October 2015 if you might be free then instead. I hope you will be able to make the exhibition but if you need any more information or if I can be of any assistance at all then please do not hesitate to contact me. 
